

BACKGROUND

COMPANY HISTORY

In 2007 Kariega International Consulting (KIC) was incorporated in Port Elizabeth with a strategy to provide foreign multinational companies with quality business and finance administration solutions. Since its incorporation, the company serviced customers in North America, Latin America, Europe, India and across Africa.

Over a period of time it became increasingly clear that there was a tremendous need for comprehensive business solution services, especially among Small to Medium Sized Enterprises (SMEs) and in bigger organizations on a project basis. It was also clear that this phenomenon was not industry or region specific with an abundance of opportunities to be of service globally and in domestic, South African markets.

As part of this company's vision to provide a comprehensive service suite, including finance, marketing and IT solutions, KIC was rebranded as Hyperion Business Solutions (HBS) in 2015. At the same time and with this vision in mind, HBS started an association with Undercurrent Studios and its principal, Peter-David Douglas. It was soon clear that there were natural synergies and a shared vision. On 1 July 2015 Hyperion Studios was launched as Marketing Division of HBS with Mr Douglas assuming control of the division as Creative Director.

Throughout KIC's history in the Latin American markets, it worked closely with an IT solutions provider, MainTech. MainTech is entrenched at a global level, offering its services to and from almost any place, worldwide. On 1 September 2015 the principal of MainTech, Mr Samuel Toyber, was appointed as IT Director of Hyperion Technologies, the IT division of HBS, specifically to service multinational clients.

These were the first steps towards offering a full scope business solution package through HBS and Hyperion Unlimited's Network of Associated Companies.
